## **APPLICATION FOR ART & CRAFT VENDORS**

### **RULES:**

1. All work exhibited must be original and handcrafted by the artist.
2. Only one artist (or team) per exhibitor space.
3. Booth fee is \$15.00 per booth. Make all checks payable to **VIA, Inc.** (no money orders). Your booth fee will be cashed when it is received.
4. Booth sizes are 12' x 12'. Artists are responsible for their own property and for furnishing their own tents, tables, chairs, and change. Be prepared for sun, wind, and rain. **No electricity is available.**
5. Artists are responsible for insurance and protection of artwork and display. VIA, Inc will not be responsible for damage to artwork or display.
6. Deadline to register is April 22<sup>nd</sup>, 2017 or when filled. All vendors must check in at registration table located at the VIA booth located near the park gazebo to **obtain space before setting up their exhibit.**
7. **NO REFUNDS FOR CANCELLATIONS.** No refunds will be given due to the cancellation of the event by, an act of god, local authorities, or a weather-related incident.
8. Name of vendor must be displayed prominently at booth.
9. Artists are responsible for collecting and forwarding 6.5% Florida State Sales Tax to the Department of Revenue.
10. Absolutely all inventory, boxes, artwork, etc. must be contained within your booth space and cannot interfere with adjacent exhibits or walkways in anyway.
11. Exhibitors are responsible for leaving a clean area after closing.
12. Exhibitors agree to conduct themselves in a respectful, cooperative manner. Any behavior deemed inappropriate by VIA, Inc. may result in expulsion. Art in the Park is a family friendly event and event committee does not wish to include radical, disturbing displays or outbursts at this event.
13. Pets are allowed **only if owners clean up after them and maintain control over them at all times. Pets are not allowed in the display area.**
14. When any rules are violated, the event committee reserves the right to ask the artist to leave the show, or remove the offending piece of work.
15. Additional information concerning set-up procedures and directions will be sent to accepted artists.

(VIA, Inc.) and all other participating and sponsoring organizations from any responsibility, personal liability, loss or damage in connection with this event.
